- **Form 700, Statement of Economic Interests** – Must be filed with the City Clerk by all Commissioners pursuant to State Law, and it becomes a matter of public record. The form requires a disclosure of real property (excluding your home), investments other than retirement, certain gifts you may have received, and other financial disclosures. Form 700 is filed by the City Council, all Commissioners, and many City staff members, and will be provided to you after your appointment to the Commission.
- **Ethics Training** – All City Commissioners are required to complete a two-hour Ethics Training course once every two years. Information will be provided to you upon your appointment to the Commission. The Certificate of Completion is kept on file with the City Clerk.
